Annex 2 - Conditions Consistent with the Operating Schedule

All exits doors to be easily opened without the use of a key, card, code or similar means and will be available for egress while the public are on the premises.

Means of escape will be maintained unobstructed, immediately available and clearly identifiable.

Exit doors will be regularly checked to ensure they function satisfactorily.

All fire doors will be self-closing, maintained effectively and shall not be held open other than by approved devices.

Curtains, hangings and temporary decorations will not obstruct exits, fire safety signs or fire-fighting equipment.

Notices detailing the actions to be taken in the event of fire or other emergency will be prominently displayed and maintained in good condition.

Access will be provided for emergency vehicles and this access will be kept clear and free from obstruction.

All signs for fire exits and means of escape will be in accordance with BS5499.

Exit doors will open outwards (or will be secured in the open position).

When disabled people are present, adequate arrangements will exist to enable their safe evacuation in the event of an emergency.

An adequate and appropriate supply of first aid equipment and materials will be available on the premises.

The noise emanating from the premises should not cause a nuisance to inhabitants of the neighbourhood under any circumstance.

Prominent, clear and legible notices will be displayed at all exits requesting patrons to respect the needs of the local residents and to leave the premises and the area quietly.

Proof of age policy will also apply (at entry) for live performances and/or the showing of videos, DVDs and/or films which may contain adult entertainment and for which appropriate signs will be displayed.

Any adult entertainment or services, activities, other entertainment or matters ancillary to the use of the premises that may give rise to concern in respect of children is not permitted.

Outside area to be licensed for regulated entertainment until 11pm on a maximum of 6 days per year for events.

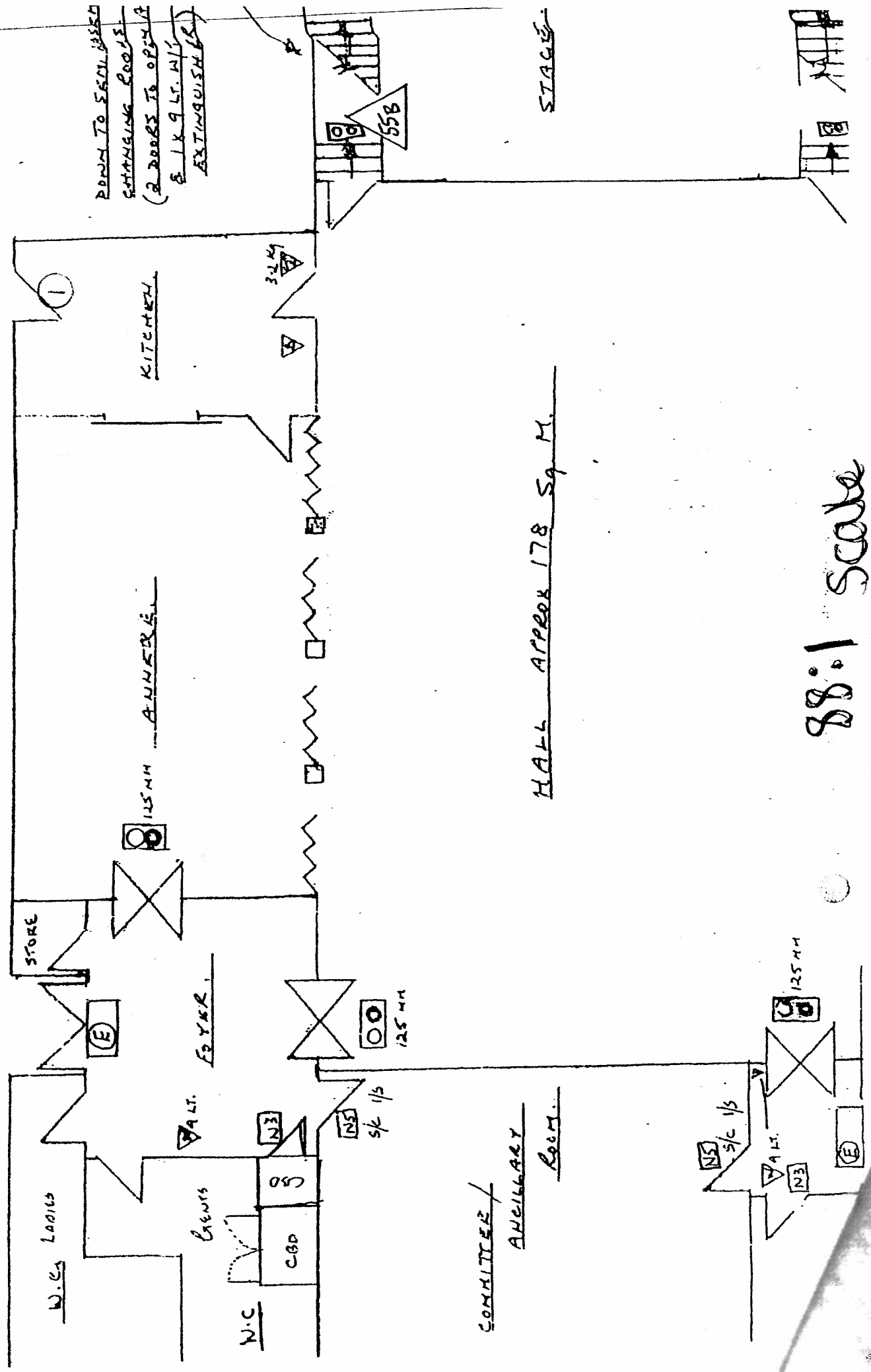

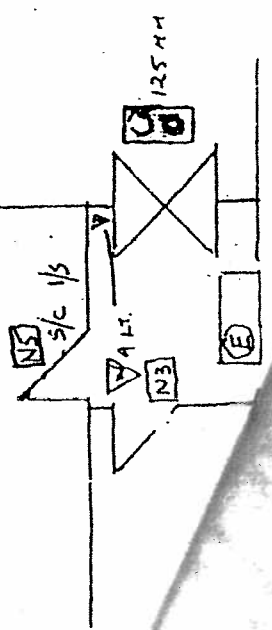

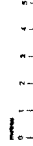
Drawing Name block plan
